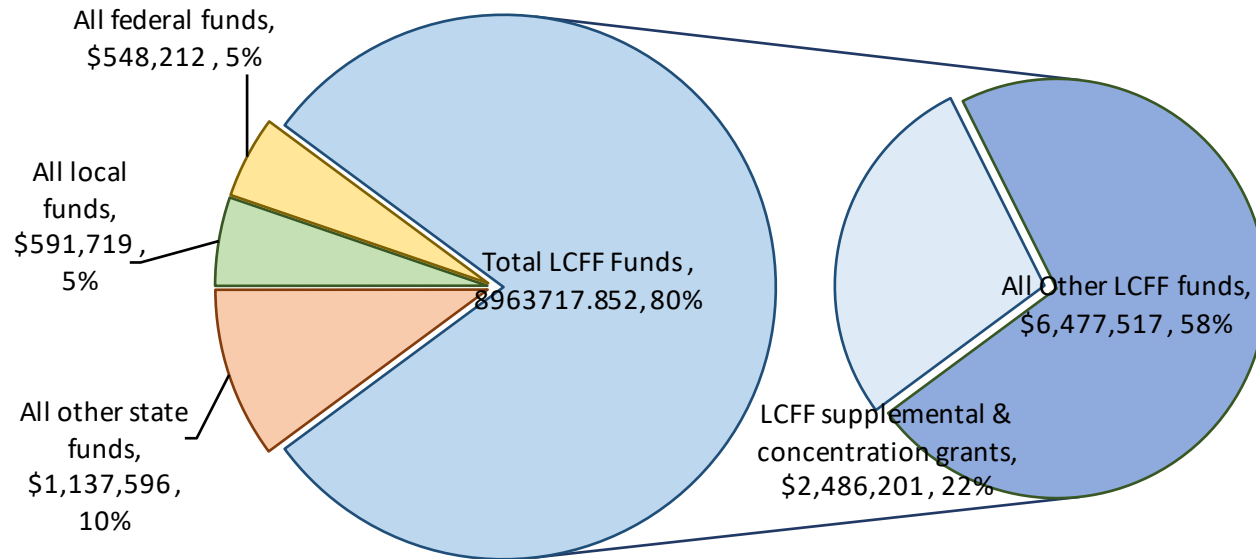

Projected Revenue by Fund Source

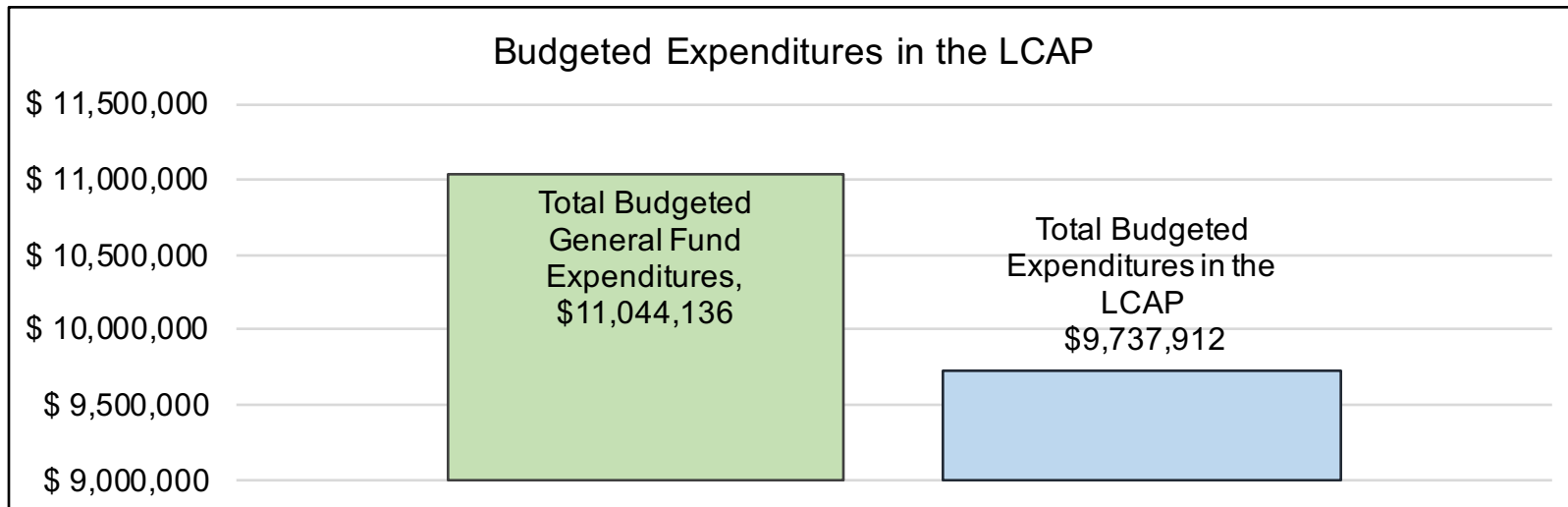

The text description for the above chart is as follows: The total revenue projected for Math and Science College Prep is \$11,241,245.36, of which \$8,963,717.85 is Local Control Funding Formula (LCFF), \$1,137,595.89 is other state funds, \$591,719.16 is local funds, and \$548,212.46 is federal funds. Of the \$8,963,717.85 in LCFF Funds, \$2,486,200.65 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

The LCFF gives school districts more flexibility in deciding how to use state funds. In exchange, school districts must work with parents, educators, students, and the community to develop a Local Control and Accountability Plan (LCAP) that shows how they will use these funds to serve students.

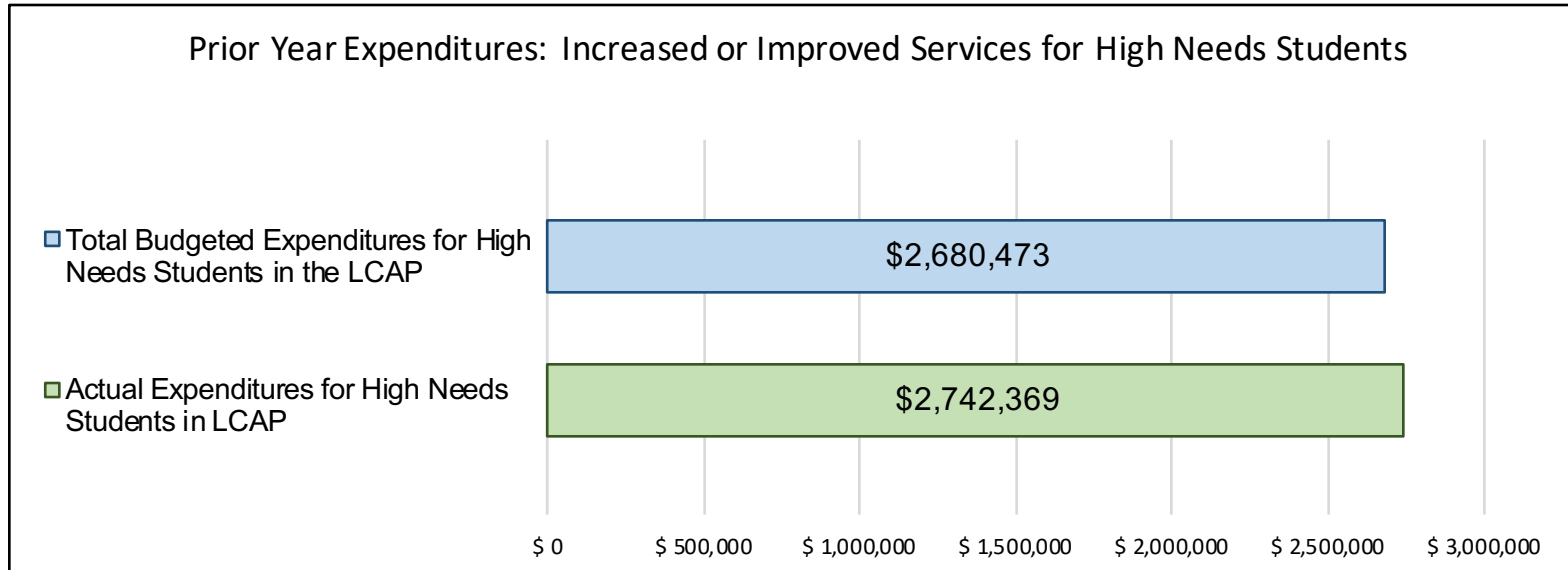

Increased or Improved Services for High Needs Students in the LCAP for the 2025-2026 School Year

In 2025-2026, Math and Science College Prep is projecting it will receive \$2,486,200.65 based on the enrollment of foster youth, English learner, and low-income students. Math and Science College Prep plans to spend \$3,563,641.58 towards meeting this requirement, as described in the LCAP.

Plan Summary 2025-2026

General Information

Math & Science College Preparatory (MSCP), a part of the the STEM Preparatory Schools, Inc. (STEM Prep) family, is one of a pipeline of 3 schools serving grades TK through 12th in the densely populated residential urban neighborhoods of Jefferson Park and West Adams located in South Los Angeles. Our families are disproportionately lower income and have attained less education than the general population of the City of Los Angeles. Most of our students will be the first in their families to graduate from college.

The vision of MSCP and STEM Prep is to create a pipeline of individuals who will transform their community by closing the socio-economic, ethnic, and gender gaps in STEM fields, and serving as role models who exhibit scholarliness, advocacy, perseverance, and kindness. STEM Preparatory Schools, Inc. (STEM Prep) is working to close the pervasive racial and gender gaps in science, technology, engineering, and math (STEM) by preparing a highly-qualified, diverse student population in STEM subjects, better enabling our students to achieve success in high-demand, high-income, high-impact careers by ensuring not only college acceptance, but also college retention, graduation, and job placement.

MSCP serves 534 students in grades 9-12. Approximately 12.1% of our students qualify for special education services and 90.4% for free or reduced-price lunch, a proxy for student poverty. Our student population is 70% Latino/Hispanic, 12% White, 8.1% African American, and 6.2% Pacific Islander. 15.2% are English Learners, and 0.6% are Homeless.

MSCP is not eligible for Equity Multiplier funding. As a Title I School-Wide Program, MSCP uses the LCAP as its SPSA, accounting for both LCFF and Title spending priorities within one planning document.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

A review of the 2024 California School Dashboard shows continued strength in our Suspension Rate (Blue), continued strength for English Learner Progress (Green) and Graduation Rate (Blue), a slight decline in the College/Career indicator (Orange), an increase in scores on English Language Arts (Green) and a small decline in Mathematics (Orange).

Our suspension rate held at 0.2%, well below the statewide average of 3.2%. African-American students were the only group that saw an increased, going from 0% in the previous year to a 2.3% suspension rate (Orange). A 0% suspension rate was achieved for English Learners (ELs), Long-Term English Learners (LTELs), Hispanic, and White students (all Blue). Students with Disabilities (SWD) maintained a 1.5% suspension rate (Green), and Socioeconomically Disadvantaged (SED) students maintained a 0.2% suspension rate (Blue). MSCP maintained a 0% expulsion rate. Student climate data showed an 5.7% decline in student sense of safety, going from 86.7% to 81%.

English Learner Progress improved to 50.7%, a 2.1% increase that built on the previous year's strong growth and put MSCP above the state average. LTELs did slightly better, with 51.6% making progress (Yellow). There was no increase in the percentage of ELs who decreased at least one ELPI level.

We are extremely proud of our continued strong graduation rate of 98.3%, well above the state average of 86.7%. All student groups were either identified in the highest Blue category or at 100% with no color.

Our College/Career rating exceeded the state average of 45.3% with 49.2% of MSCP students considered "prepared"--a decline of 2.4% from the previous year. For Hispanic students, the rate was slightly higher at 50.9%, while SED students were slightly under the schoolwide rate at 48.7%. Readiness for ELs and LTELs declined significantly, with only 13% of ELs deemed prepared and 9.5% of LTELs were considered prepared, SWD saw a 10.7% increase, with 25% considered prepared, well above the state average. 28.6% of Homeless students were prepared, also above the state average. Of the remaining 50.8% of students schoolwide, only 1.7% were considered "Not Prepared"--the remainder were classified as "Approaching Prepared."

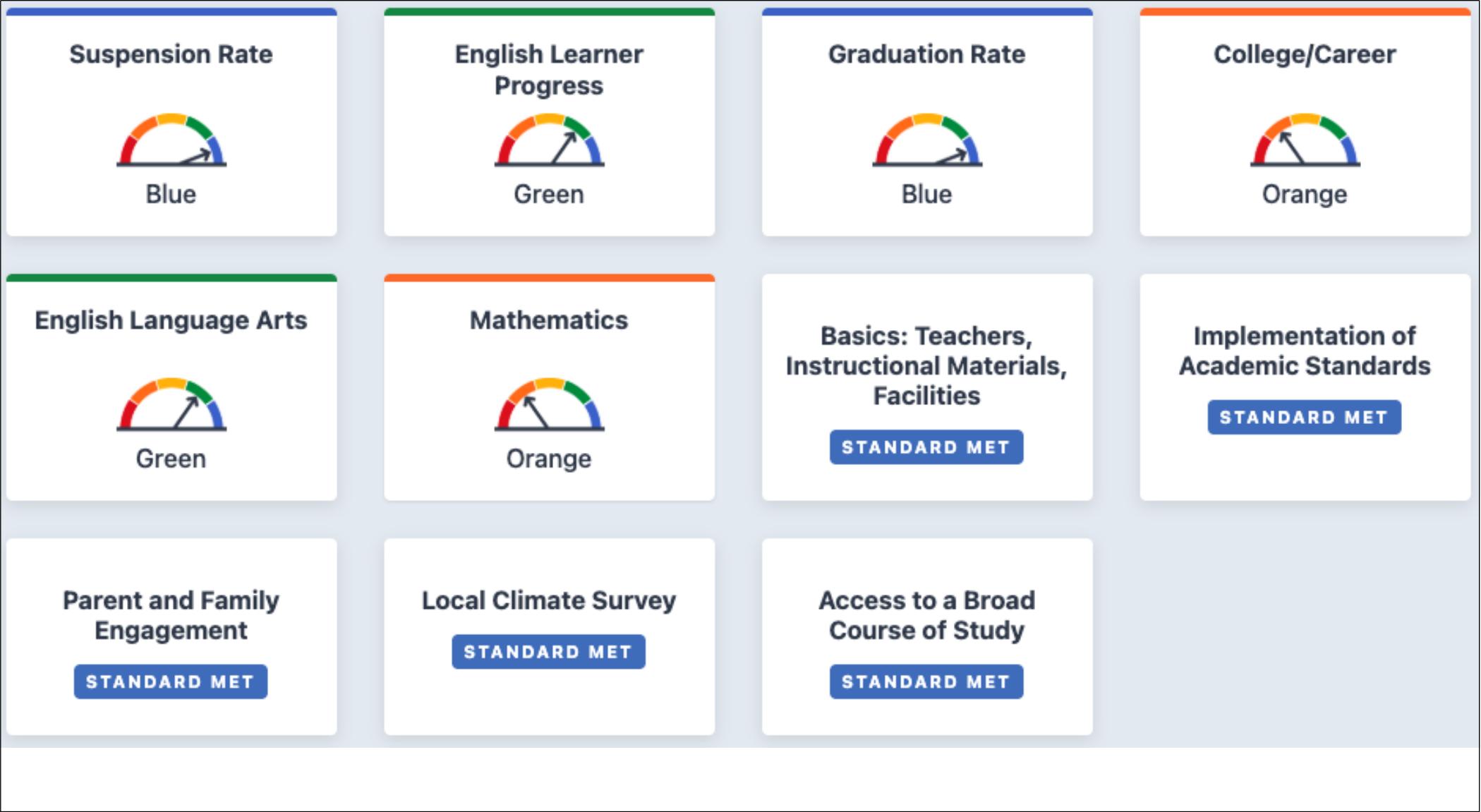
CAASPP performance for English Language Arts improved by 13.4 points to 30.1 points above standard, 43 points above the state average. No student groups were classified in Red, Orange, or Yellow. Performance for SED students was just behind schoolwide performance, with an increase of 10.1 points to 26.4 points above standard. Hispanic students outpaced the schoolwide growth, improving by 22.2 points to 37.4 points above standard. Students with Disabilities again improved performance by a remarkable 39.8 points to 20.9 points below standard, more than 70 points above the state average. ELs had similar dramatic growth, increasing 39.6 points to 52.1 points below standard, beating the state average. LTELs also saw a strong improvement, growing by 22 points to 86.8 points below standard, well above the state average. African-American students scored an average DFS of 28.5 points below standard, also well above the state average.

CAASPP performance on mathematics declined by 2.1 points to 99.3 points below standard. Performance for Hispanic students and SED students was similar, both with a decline of 1.1 points for a DFS of -98.9 and -99.6 respectively. Performance for English Learners, however, increased by 22.5 points to 162.3 points below standard. SWD saw even more dramatic growth, climbing 69.2 points to -138.6 DFS. LTELs unfortunately saw a steep decline of 31.3 points, with a DFS of -219.8.

The California Science Test (CAST) showed slight improvement overall, with proficiency growing by 2% to 27.5%. SED performance matched that of the school, while Hispanic students increased by 3% to 29%. 15.4% of African-American students met or exceeded the standard. 0% of ELs met the standard, and performance declined for SWD to 11.8% meeting or exceeding the standard.

Note: MSCP did not have any Dashboard items or student groups at the lowest performance level in 2023, thus those items are not mentioned here as they are not applicable.

MSCP has \$73,058.84 in unexpended Learning Recovery Emergency Block Grant (LREBG) funding which will be spent in the 2025-26 school year. This funding will be used to support academic achievement for students as described in Goal 3, Action 1 - Differentiated Instructional Supports and Goal 3, Action 3 - Instructional Leadership and Support. In Goal 3, Action 1, LREBG funds will be used to provide students with evidence-based instructional materials to help close learning gaps, specifically through the use of iReady in both Reading and Mathematics. In Goal 3, Action 3, LREBG funds will be used to provide instructional aides to support academic achievement. This is an allowable use of funds which both improves staff-pupil ratios and provides evidence-based learning supports to close learning gaps. Research has shown that trained instructional aides who deliver targeted interventions, especially in literacy, can lead to positive gains in student attainment. This intervention will help MSCP address academic achievement rates for all students, but particularly the student groups discussed above, including African-American students, SWD, ELs, and LTELs.

Principals and Administrators	Principal and administrators are actively involved in the LCAP process, reviewing and providing data for the mid-year update, helping directly craft goals, actions, and goal analysis, and presenting information to the educational partners as described above.

A description of how the adopted LCAP was influenced by the feedback provided by educational partners.

Teachers and staff expressed appreciation for the streamlined use of academic technology and responsive IT support, a continued area of investment. (Goal 3, Action 5).

Parents and students emphasized how much they valued the teachers and their commitment to their students. They were concerned about retaining strong teachers and staff, as were teachers and students. This priority helped shape the structure of Goal 2, and is further reflected in Goal 2, Action 4, which focuses on talent support.

Parents stated that parent-school communication was very strong, and should be a continued priority. This is a key element of Goal 1, and is part of Actions 1 and 3.

Students and parents expressed desire for additional support for sports and field trips, which are part of the investments made in Goal 1, Action 3.

Parents emphasized how much they valued the additional academic supports given to children based on their needs, a commitment that is further developed in Goal 3, Action 1 and 3.

Parents felt that additional attention needed to be paid to student culture, with emphasis on behavior, discipline, and attention to diversity. These investments are addressed in Goal 3, Action 1.

An explanation of why the LEA has developed this goal.

One of our Core Values is that we are a family, and we build our legacy by caring for, learning from, and supporting each other.

While our 2023 Chronic Absenteeism rates have improved slightly, they currently still exceed the state's rates. Additionally, we are committed to maintaining and improving our low suspension rates.

Our school's root cause analysis has seen a correlation between our student climate survey results (most recently 74%) and schoolwide attendance rates (92%) and chronic

absenteeism rates (27.4%).

We believe that when our students feel cared for and supported and their parents are actively engaged, student attendance improves, ensuring every student has equal access to an inspiring and rigorous curriculum to support their learning. We will achieve this goal through continued investments in counseling, restorative justice, parent engagement and strong operational support that every student and family receives the support they need.

2024-25 Update:

These trends continued in 23-24 data; attendance rates declined slightly as absenteeism increased and student climate survey results declined. The need to prioritize these areas remains.

There were no material differences.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

These actions were somewhat effective in making progress towards our goal. While attendance and chronic absenteeism did not improve, suspension rates remained extremely low and declined for ELs and LTELs. Our expulsion rate remained 0%, and our dropout rate declined to 0%. A "Good" FIT rating was maintained, as was the highest rating for Parental Engagement. While survey results for families and students declined slightly, results remained fairly strong overall.

Action 1 - Effective Operations Management allowed us to maintain a strong base of communication and efficiency, including strong parent communication and record-keeping that supports a 0% dropout rate.

Action 2 - Safe and Compliant Facility allowed us to maintain our "Good" FIT rating. There was a slight decline in perceptions of student safety, which will continue to be an area of focus.

Action 3 - Multi-Tiered System of Supports (MTSS) for Student Engagement and School Culture was partially effective as seen through a reduction in absenteeism for ELs, suspension rates, expulsion rates, and dropout rates. However, overall absenteeism and attendance, as well as student connectedness, did not improve and need further investment.

Action 4 - CMO-Level Support for Student Engagement and School Culture was also effective as seen through a reduction in absenteeism for ELs, suspension rates, expulsion rates, and dropout rates. Additional targeted support will also be needed from these roles in addressing absenteeism, attendance, and student climate.

These actions were largely effective, as the school was able to maintain success on every metric other than teacher satisfaction, which declined to 78.95%.

Action 1 - Standards Aligned Instructional Materials, allowed MSCP to maintain success in both standards implementation and student access to materials, including for English Learners. This helped ensure students had access to materials supporting their A-G course completion as well.

Action 2 - High-Quality Teachers and School Leadership ensured that MSCP maintained a "Met" rating for teacher credentialing on the LAUSD oversight visit, as well as a strong implementation of state standards and access to Integrated and Designated English Language Development for ELs. These are essential components of our college-readiness approach.

Action 3 - Special Education Program ensured that all compliance requirements were met for students with disabilities, including access to a broad course of study that allows for A-G course completion.

Action 4 - CMO-Level Talent Support also helped ensure that MSCP maintained a "Met" rating for teacher credentialing on the LAUSD oversight visit.

Action 5 - Project Lead the Way supported our broad course of study for all students.

While we have seen some meaningful growth on CAASPP, student results are still falling short of our targets and pre-pandemic success rates, particularly in math and for certain subgroups. Although English Learner Progress has improved, it is currently below the state average, and we recognize the need for ongoing focus on these students to help their growth in language proficiency translate into academic success.

2024-25 Update

While results in ELA continued to improve, mathematics results were mixed, and CAST results declined slightly. EL progress on ELPAC increased slightly, but reclassification rates declined by a slightly larger rate. Overall, the need for a comprehensive array of actions to support our student population remains.

EL progress was similarly mixed but strong, with EL reclassification decreasing slightly while ELPI declined but remained above the state average.

Action 1 - Differentiated Instructional Supports, Action 2- Professional Development, and Action 3 - Instructional Leadership and Support Staffing ensured that students had access to effective instructional strategies, targeted intervention support, relevant materials, and other differentiation, helping drive the increases described above.

Action 4 - ELD Program helped drive the EL performance growth described above through strong professional development, effective ELD curriculum, and trained instructional leadership.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.
- **13. LCFF Carryover — Percentage (12 divided by 9)**
 - This percentage is the unmet portion of the Percentage to Increase or Improve Services that the LEA must carry over into the coming LCAP year. The percentage is calculated by dividing the LCFF Carryover (12) by the LCFF Funding (9).
